Unfortunately, the original version of the article [1] contained an error. A typo in the main equation (Eq. 1) has been introduced during the production process. The operator “=” in Eq. 1 “ $\log(\theta_{ik}) = \alpha + u_i \dots$ ” was missing.

The equation should read as:

$$\begin{aligned} Y_{ik} &\sim \text{Poisson}(\mu_{ik}) \\ \mu_{ik} &= E_i \theta_{ik} \\ \log(\theta_{ik}) &= \alpha + u_i + v_i + w_j + g_k + \beta'_1 X_{ik} + \beta'_2 X_j \\ \beta_* &\sim \text{Normal}(0, \tau_*^{-1}) \\ \tau_*^{-1} &\sim \text{Gamma}(2, 1) \end{aligned} \quad (1)$$
